Introduction

WA Seniors Week 2024 is a time to celebrate the contributions of Western Australian seniors. From **Sunday, 10 November 2024 to Sunday, 17 November 2024**, events and activities will take place across the State to recognise seniors and express our appreciation for their invaluable role in the community.

COTA (WA), with support from the Department of Communities, invites local governments, registered not-for-profit organisations, and community groups in Western Australia to apply for funding to host events or activities during Seniors Week. These grants aim to celebrate the role of seniors in our communities and promote greater participation in community life, particularly for those who may be socially isolated.

Community Grants Available

Grants of up to \$1,000 are available to local governments, registered not for profit organisations and community groups (or up to \$3,000 for a consortium) throughout metropolitan and regional Western Australia, and in particular rural and remote areas, to support seniors, particularly those who experience disadvantage or isolation, to attend events and activities during Seniors Week 2024. Each recipient organisation will be asked to provide a summary of the event and acquittal of funds.

Objectives

The 2024 Seniors Week Community Grants Program provides financial assistance to organisations hosting local events in metropolitan and regional areas of Western Australia.

Events should meet at least one of the following aims of the week which are:

- To recognise and thank seniors for their contribution to the community.
- To promote intergenerational activities linking seniors to the community.
- To facilitate artistic, cultural and celebratory expression within the community.
- To engage seniors in a variety of activities and initiatives that encourage active ageing.

Proposals are strongly encouraged for events aimed at seniors who:

- Would not normally participate in Seniors Week activities or events.
- Are at risk of becoming socially isolated.
- Are members of Indigenous and Culturally and Linguistically Diverse communities and LGBTQIA+ communities.

What can be Funded

Funds received through this program may be used as a contribution towards program costs. Such expenses may include, but are not limited to:

- Advertising and promotion
- Catering, food and drink
- Entrance and/or admittance fees
- Project materials
- Transport costs
- Venue and equipment hire
- Other miscellaneous expenses.

What cannot be Funded

The grant **cannot** be used for:

- Prizes and gifts, including cash or vouchers
- Capital equipment purchases
- Ongoing operating or administration costs, including staff wages
- Interstate or overseas travel
- Fundraising projects
- Purchase of alcohol.





Special Conditions of Grant

- Funded activities and events to be held during WA Seniors Week 10-17 November 2024.
- If the project involves working with children, the Organisation must ensure that all employees and volunteers comply with the *Working with Children (Criminal Record Checking) Act 2004*.

- The Grantor is not liable for any accident or negligence resulting in any claim or damage arising from activities undertaken as part of the Grant. In this respect, the Organisation is required to be appropriately incorporated and be responsible for its own insurances. This includes but is not limited to, Public Liability, Volunteer Insurance and Professional Indemnity.
- The Parties agree that the State will not, by virtue of the Grant, obtain ownership of any intellectual property in or in relation to any material developed by the Organisation (other than material created by the State or provided to the Organisation by the State).
- The Organisation grants to the State a perpetual, irrevocable, royalty-free, world-wide, nonexclusive licence to use, reproduce, adapt and publish the whole or any part or parts of all promotional materials, resources, data and reports brought into existence by or for the Organisation in connection with this Agreement or the Organisation's use of the Grant.
- The Organisation must ensure that participants in the Project are not exposed to significant promotions of alcohol or unhealthy food and drinks during the Project.
- Activities should align with <u>Good Practice Requirements</u> where relevant.

An acknowledgement of funding assistance provided by the Grantor must be included in any advertising and on any material relating to the Project by displaying the Grantor's logo and using the words 'Supported by the Department of Communities'. Copies of the logos and guidelines for its use are available by contacting the Grantor.
